SELLER AGREES:

- To provide a copy of deposit contract to Buyer once payment is received.
- That deposit amount will be deducted from total price of puppy.
- Deposit is non-refundable for any and all reasons possible. Seller owes no debt to Buyer if
 for any reason Buyer does not complete payment or changes mind about purchasing a
 puppy.
- Deposit is transferable to future litters up to and not to exceed three times after the original intended litter. After three transfers, the deposit is considered cancelled by the Buyer. No refund will be made by the Seller and should the Buyer inquire about future litters again, a new deposit must be placed.
- To notify Buyer of date that remainder of payment is due.

BUYER AGREES:

- That deposit amount will be deducted from total price of puppy.
- Remainder of total price of puppy is due to be paid the day the puppy is transferred ownership from Seller to Buyer.
- That deposit is NON-REFUNDABLE for any and all reasons possible. Should Buyer change their mind about purchasing a puppy, not pay in full at the time of transfer or ANY

- other reason that results in Buyer NOT receiving a puppy, NO REFUND will be made in ANY amount.
- That placing a deposit holds the pick order for a future puppy. NO REFUND will be given if the timing of litter changes for any reason including but not limited to breeding not taking for all reasons beyond the sellers control. In this scenario the buyer will be asked which future litter they would like to move the deposit to.
- Deposit is transferable to future litters up to and not to exceed three times after the original intended litter. After three transfers, the deposit is considered cancelled by the Buyer. No refund will be made by the Seller and should the Buyer inquire about future litters again, a new deposit must be placed.
- To collect puppy by 10 weeks old. Should Buyer NOT collect puppy by 10 weeks old without prior arrangements for extended boarding being discussed, the puppy and ALL funds, deposit and remainder of final payment, are forfeited by Buyer to compensate Seller for food, vet care and housing until puppy is placed in a new home.

TERMS OF CANCELLATION

As the breeder, raiser and inherent caretaker of the puppies, Seller reserves ALL RIGHTS to cancel sale at ANY point in time and for ANY reason Seller deems fit. Should Seller cancel sale, Buyer will receive a refund of the deposit amount and any monies paid toward the total sale price of the puppy EXCEPT if cancellation of sale is due to Buyer backing out for any reason including but not limited to: change of mind, not completing payment at time of transfer, failure to pick up puppy by 10 weeks of age, in which case NO REFUNDS in any amount will be made.
